### UMBRELLA WARRANTY

Summer Classics Contract warranties our two piece fiberglass ribbed Market Umbrellas and bases for a period of one year from the date of purchase, to the original purchaser, against defects in materials and workmanship. Additionally, fiberglass support ribs on the Market Umbrellas are warranted for five (5) years from the date of purchase. Augusta, Bridgewater, Lucaya, and Riva Collections are warranted for a period of five (5) years from the date of purchase, to the original purchaser, against defects in materials and workmanship. Fiberglass support ribs on these umbrellas are also warranted for five (5) years. For the warranty to apply, all umbrellas must be secured in a properly weighted base. Though our umbrellas have successfully passed wind tests over 50 miles per hour, it is not recommended allowing umbrellas to remain open during storms or strong winds. Customer is responsible for taking the umbrella down when winds reach unsafe conditions. Normal care and maintenance of products is required to insure years of problem free use. Damaged umbrellas should be immediately taken out of service. This warranty does not cover the umbrella pole, crank or tilt, normal fading of fabrics and finishes and chemical stains. This warranty does not cover any damage due to acts of God, abuse, misuse or vandalism incurred to the umbrella after purchase, nor does it cover customer's own material. For warranty to apply products must be properly cared for and maintained. Modifications made to the product after production may void warranty. This warranty does not provide coverage or reimbursement for loss of use, time, inconvenience or other damages resulting from any defect in the product. No returns will be accepted without prior approval.

### FABRIC WARRANTY

Fabric options offered vary by product. Marine grade solution dyed acrylic fabrics are warranted against light fastness for a period of six (6) to ten (10) years depending on the fabric mill. Furniture grade solution dyed acrylic fabrics and acrylic blends are warranted for a period of five (5) years. The fabrics are covered under a limited pro-rated warranty provided directly from the fabric mill. This warranty covers the fabric becoming unserviceable because of loss of color or strength from normal exposure conditions including sunlight, mildew rot and atmospheric chemicals. It does not cover labor and installation supplied by Summer Classics Contract. In the event that your fabric fails, please contact us to inspect fabric, submit a claim and secure replacement fabric. All fabric must be properly maintained and cleaned regularly for the warranty to be effective. COM fabrics are not warranted.

### RETURNS:

Authorization is required on all goods returned. Please contact our customer service department for a Return Materials Authorization (RMA) number and instructions. No credit will be allowed for goods returned without our written consent. Custom items may not be returnable due to the nature of the product.

### CLAIMS:

All claims for shortage must be made within five (5) business days after receipt of goods. Claims for all collect or third party shipments must be made with the carrier for damages and shortages that occur while in transit. At the time of delivery, any visible damage or shortages must be noted on the freight bill. Packages should be opened immediately and inspected for concealed damage.

### CUSTOM ORDERS:

Varieties of custom options are available and can include: custom designs, sizes, finishes, fabrics, logos, trim, etc. Due to the nature of custom products, a 50% deposit is required before production can begin. Custom orders can not be cancelled once entered into production.
